



Such famous names included those who have changed the cultural and scientific history of humanity, from Copernicus to Vesalius, Galileo, to William Harvey, to the more modern Tullio Levi-Civita, Concetto Marchesi, Giuseppe 'Bepi' Colombo and many others.

The University of Padua has been a proud pioneer of several endeavours, including the first university botanical garden in the world founded in 1545 that now holds it s status as a UNESCO World Heritage Site. In 1594, the first permanent anatomical theatre was inaugurated, and in 1678, Elena Lucrezia Cornaro becomes the first woman in the world to receive a Doctor of Philosophy degree.

Today, the University of Padua counts over 70,000 students (over 7,000 international students) and 2,200 teaching Staff within its **32 departments**, and **8 schools**.






The sixth was held again in Valencia (Spain) in 2023.
